## Rust & metallic stain remover

### PRODUCT

Its effective in the removal of stubborn yellow and dark coloured stains caused by metals like iron, copper etc. its safe to use on textiles, carpets, upholstery etc. The formula begins working on contact, dissolving the oxidation that causes these stains. Easy to use, spray directly onto stained area and rinse off. No heavy scrubbing needed.

A brush, sponge, spoon or an edge of a knife can be used to treat the stain until the stain is gone. The application area is rinsed off and the washable textile is washed in the normal washing process. Spotaway 2 should be tested in a small place of the textile before use. Since the product is acidic, long exposures on marble surfaces should be avoided.

Spray Spot away 2, directly on surface to be treated. Let product work until stain is gone before rinsing area with fresh water. Deep stains may require a second application and light scrubbing with a brush or cloth. Test area to be cleaned for colour fastness in an inconspicuous area before proceeding with spotting.

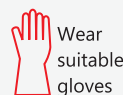
