### APPLICATION

2. Heavily stained areas may need light brushing with gentle bristle brush.
3. Work from the outside to the centre of larger soiled areas to control spread of contamination.
4. Repeat as needed. Large and old spots will definitely need repeat treatments as contamination has likely penetrated the fibres.

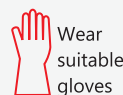
